



Call for Poster and Display Presentations

2014 Clyde Martz Summer Conference Water and Air Quality Issues in Oil and Gas Development: The Evolving Framework of Regulation and Management

June 5th-6th, 2014 University of Colorado Law School

The **Getches-Wilkinson Center for Natural Resources, Energy, and the Environment** invites you to tell your story on water and air quality related to oil and gas development via a Poster/Display Presentation. As part of its annual summer conference, the GWC will host a poster/display session that is open for participation to all conference attendees. Posters/Displays can be developed by an individual or group. The format, content, and guidelines for this session are presented below.

HOW TO PARTICIPATE: By Thursday, May 15th submit your intention to participate.

Send the intent statement to shaun.labarre@colorado.edu (303-492-1286) and include:

- Title of poster/display,
- Names and affiliations of presenters/contributors
- Contact information (address, phone, email, website address)
- 100-word abstract/description of poster content,
- Dimensions of the poster (typically 4 feet by 3 feet) or requests for a table or a space for a larger poster. Requests for table or other display spaces, including electric outlets, will be accommodated when possible. PLEASE BE SPECIFIC regarding these requests!

TOPIC: Posters/displays should address **recent** or **ongoing water and air quality issues in oil and gas development** through research projects, research capabilities or techniques, or ideas for future research directions. Commercial entities are welcome to submit posters/displays that address these topics beyond simply advertising or promoting company products and services. **PRESENTATIONS:** The poster/display session will be held on **Thursday evening**, **June 5th from 5:00 – 7:00 pm.** Posters may be on display by 11:30, June 5th for informal viewing during the Thursday conference lunch, although displays requiring tables may not be accommodated until after the luncheon.

Because the conference evening reception begins at 5:00 pm (immediately following the last panel discussion), posters/displays must be installed by 4:00 pm. Volunteers will be available Thursday morning and afternoon to help with the logistics of locating posters/displays. Posters/displays must be removed after the reception on Thursday evening.

The location for the Poster/Display session is a public café area that will not be secured during the conference sessions. GWC does not accept responsibility for material left behind, lost, stolen or damaged.

SIZE/DESIGN GUIDELINES: Posters are generally **4 feet high** by **3 feet wide.** To create a poster, we suggest that you use Photoshop, Adobe Illustrator or Microsoft PowerPoint and set the margins at 36" x 48".

- Titles are typically at least 28-pt type. Subsequent headings should be boldfaced and at least 24-pt type. The title of your poster should be strategically located to allow viewers to identify your topic easily. Indicate author(s) names and address information in case the viewer is interested in contacting them for more information.
- Diagrams or charts should be in a size sufficient to be read at a distance of 5 feet. Paragraphs and figure captions should be at least 20-pt font. A serif font (Times) is often easier for reading text, and a non-serif font (Arial or Helvetica) for headers and figure labels.
- Poster information should include the background of your topic/research, results and conclusions.
- Videos or high-tech motion graphics, computer demonstrations, etc. will be accommodated when possible. Guest internet will be available in the poster session venue (Wolf Law Building Café). Presenters should provide all necessary Audio/Visual equipment, including extension cords.
